incident the prior day that involved an individual fleeing with a stolen gun; both were recovered. The sheriff addressed a gas bill from Alexandria, Minn. (where a light bar had been taken for repair) and one from O'Reilly that will be refunded. Sheriff Rode also addressed a bill for sheriff's office pens that Commissioner Horner considered excessive. The sheriff said that pens had been purchased in previous years and he did not understand what the issue was now. Commissioner Horner stated that he did not think purchasing pens was a good use of public funds, and since some of them said "Sheriff Rode" and were to be paid with public funds, the pens may conflict with campaign laws. Sheriff Rode said he did not campaign with the pens, and since the bill hadn't been paid after several months, there were now finance charges. He commented on merchandise that a previous sheriff ordered with his name on it. County Auditor Erickson said that the state's attorney had advised the previous sheriff to discontinue that practice. Commissioner Horner said that he had received comments about the pen purchase. The sheriff replied that he had gotten positive feedback. Commissioner Kuk read an email reply from the sheriff earlier this month that addressed the pens. Commissioner Davidson recommended not having names

on the pens going forward, but otherwise did not feel it was a major issue. The commissioners approved a motion to pay the bill for the pens with the stipulation that they not contain personal identification. The motion carried, with Commissioner Horner voting no.

State's Attorney Wang discussed the reversionary clause that the county adopted in 2013 regarding property that returned to the county for unpaid taxes. The clause (or restrictive covenant) required that property taxes continue to be paid on the purchased property, in effect excluding non-tax-paying entities from buying the forfeited parcels. The state's attorney reviewed his correspondence with other attorneys who urged that the clause be removed, citing equal protection laws, ND Century Code and a 1962 court case. In the interest of avoiding legal action, the state's attorney recommended that the commissioners undo the restrictive covenant and make it retroactive. The board voted to do so. Chair Stadum asked if the board would be exposing itself to backlash. State's Attorney Wang did not think so. He recommended that purchasers of forfeited property receive direct notice that the clause had been revoked.

The board approved a motion to reappoint Oscar Kleven, Valerie Wood, Donald Hanson and Doris Griffin to the Benson

County School Reorganization Board for three years beginning May 7, 2025.

The commissioners revisited whether to install cameras in the commissioner room to livestream the meetings and/or act as a security measure. Commissioner Davidson asked the board if they wanted to "go live." Commissioner Kuk said that it had been a goal of hers since being elected. Commissioner Horner asked if the public could request access to the meeting through Microsoft Teams; County Auditor Erickson said they could. Commissioner Kuk asked whether the public could watch the Teams recordings later, and said that YouTube was her preference. She stated that a camera in the commission room added to the board's transparency and could deter disruptive behavior if attendees knew they were being watched by the public. Chair Stadum said he liked the idea of having a camera and microphone to record the meeting, but did not want the commission meetings to be seen as entertainment. Commissioner Griffin reviewed the methods already available for the public to learn what happens at commission meetings.

The board concluded to advertise that Microsoft Teams recordings of the commission meetings could be made available on request and to see whether they could be placed on the Benson County website.

County Auditor Erickson revisited the issue of owing money to Ramsey County for indirect social services costs. She indicated that further review found that the Ramsey County auditor's office had money on hand that had never been distributed, so Benson County does not owe anything and actually should receive money back. Commissioner Horner suggested that Ramsey County, host for the Mountain Lakes Human Service Zone, have more control over social services accounting.

A committee is needed for the request for proposals (RFP) process that the county decided on for the Flora curve realignment. Commissioner Horner volunteered to be on the board, which will also include the county auditor and highway superintendent.

Outdoor enthusiasts reminded of wildfire potential

Outdoor enthusiasts need to be aware of ground conditions while enjoying spring activities. Increased human activity outdoors in spring, combined with dead ground vegetation and high winds, make this time of year highly susceptible to wildfires.

Because of highly variable weather patterns, ND experiences a distinct spring fire season every year. With that in mind, it's important to pay attention to the fire danger index and to follow the appropriate measures.

Hunters and anglers are urged to keep up with the daily rural fire danger index, issued by the National Weather Service, to alert the public to conditions that may be conducive to the accidental starting or spread of fires.

In addition, county governments have the authority to adopt penalties for violations of county restrictions related to burning bans. These restrictions apply regardless of the daily fire danger index and remain in place until each county's commission rescinds the ban.
