#### LAMOURE COUNTY COMMISSIONERS

The LaMoure County Commissioners met on Tuesday morning for their second meeting of the month with all the members present.

Road Superintendent Darrick Nitschke said that they are ready to submit all the paperwork for the DOT Flex Funding grants. He is working with townships for their grant applications also. In order for a township to qualify for the Flex Funding grant, they need to levy at least 18 mills to get a better ranking that will better their chances to get the money. They also cannot have over \$100,000.00 on hand to qualify. A couple of the applications were for box culverts. The crews are getting the roads prepared for winter with some blade work. The county also is putting in for repairs on the Nortonville road. They agreed to pay Cont. on Pg. 2

#### LaMoure School Board

The LaMoure School Board held their state mandated public hearing on Wednesday morning before their regular meeting. There were no citizens at the meeting to question the school's budget. This is a state mandated meeting if any public entity increases their tax levy by \$1.00 or more. The school stayed within the 3% increase that was the maximum levy allowed by the state. The total revenue from all sources will be \$5,325,843.00. This is a total increase of .07% from last year. Total budgeted expenditures will be \$5,659,132.00 which is an increase of 3.7%. The state payment for per pupil aid should be \$4,195,498 but the school actually gets \$3,115,964.00. The increase in expenditures are due to increase in staff, increase in salaries and health care costs, and just the general increase in the costs of everything the school purchases.

Mr. Carlson went over the financials for the school year so far. There is nothing out of the ordinary at this time.

Mr. Carlson said that he is still trying to adjust the bus routes so the kids are not on the bus for over an hour. He will take any suggestions to the routes.

High School Principal Mr. Isaacson reported that the baseball boosters paid the school for their summer concession stand. He said the students are doing some testing now. The schedules have all been adjusted. The cell phone policy is working well. Some kids unintentionally may have it on them. The teachers said it has been positive. The homecoming parade will be at 2:30 Friday. This way all the kids can participate. All the fall activities are in full swing. Next week will be busy Cont. on Pg. 2


