Resolution changes US Highway 281 designation

Dickey County Leader, April 10, 1975

A concurrent resolution introduced and passed by the North Dakota Senate, and later by the House has designated U.S. Highway 281 as the Canadian American Legion Memorial Highway.

Senator Robert Melland of Jamestown introduced the resolution to the Senate and representative Fern Lee of Towner took the bill before the Transportation Committee of the house and onto the house floor.

The American Legion Memorial Highway, with its northernmost beginning at Flin Flon, Manitoba, running south to the US border, is known as Highway 10. At the border it is Highway 3. It turns eastward to Dunseith, and joins 281 at Rolla, where it then runs southward to the southern border of the state, then through South Dakota, Nebraska, Kansas, Oklahoma and ends at the Mexican border near Brownsville, Texas.

Signs carrying the Legion emblem in blue and gold and the "American Legion Memorial Highway," together with the name of the town and the name of the Legion Post, will be donated by various Legion clubs in the 10 North Dakota cities along Highway 281 which have American Legion posts. The signs will be placed inside the city limits and not on state or federal highway property.

North Dakota communities involved in the project are Ellendale, Edgeley, Jamestown, Carrington, New Rockford, Sheyenne, Minnewaukan, Cando, Rolla and Dunseith.

usually anything but nice: Our collective memories of extreme *April weather are quite poor.* 

Fargo, April 17, 2025 — April weather is frequently not nice. It usually snows in April and often snows several times during the month. April snow often falls after the last of the winter snow cover has melted away, making it seem like a second winter. Sometimes it is very cold in April. It is usually below freezing for a few days in April and temperatures near and even below zero have occurred.

April can also be very warm. The date of the average first 70 degree day in is April and it has been known to reach the 80s and 90s and once, in 1980, it was 100 degrees. Warm April days are often very windy, and those warm and windy April afternoons are often extremely dry, producing desertlike conditions that are conducive to wildfires. Despite all of this, it seems our collective memories of extreme April weather are quite poor, as many of us are prone to exclaim that our extreme April weather is unusual even though it

John Wheeler: Thunderstorms will become more common in May: Usually May is when storms start getting strong enough to get weather forecasters worried.

Fargo, April 18, 2025—So far this spring, most the precipitation we have received this has been snow or sprinkles. It is pretty standard to get through April without much in the way of strong thunderstorms. Usually May is when storms start getting strong enough to get weather forecasters worried about damage and safety. The missing link is thermodynamic energy.

John Wheeler: April weather is Thunderstorms thrive in environments with warm air and ample humidity. Thunderstorms are tall weather systems built on columns of rising air.

> As the air rises, the cooling humidity condenses into liquid water up in the clouds, and the heat energy originally used to evaporate that water is released. This additional heat warms the air further, making it even more buoyant. Thunderstorm clouds look like explosions because they are, growing suddenly to heights of 6 to 12 miles. Thunderstorms are capable of making weather that is quite turbulent and occasionally violent.

> John Wheeler is Chief Meteorologist for WDAY, a position he has had since May of 1985. Wheeler grew up in the South, in Louisiana and Alabama, and cites his family's move to the Midwest as important to developing his fascination with weather and climate. Wheeler lived in Wisconsin and Iowa as a teenager. He attended Iowa State University and achieved a B.S. degree in Meteorology in 1984. Wheeler worked about a year at WOI-TV in central Iowa before moving to Fargo and WDAY..
