

ND ag leaders ask Rollins to bring back certainty for the industry

Fargo/Wheatland, N.D.. — Surrounded by a wide swath of the agriculture community on Tuesday, April 22, at NDSU's Peltier Complex, U.S. Secretary of Agriculture Brooke Rollins said she's hit the ground running to support farmers and believes strongly in putting America first.

Rollins said President Donald Trump's focus is to make America great again and that he realizes that Rollins' focus is to ensure American agriculture is great again. She said it is not lost on Washington, D.C., that large parts of the ag industry have been suffering from paper-thin margins in recent years.

Rollins met with industry members from the corn, soybean, wheat, pulse, sunflower, canola, potato, sugarbeet and cattle industries along with North Dakota dignitaries. Rollins listened to the group during a roundtable in the morning before heading out to tour Grand Farm Innovation Campus in Wheatland and wrapped up the day with a visit to American Crystal Sugar in Moorhead, Minnesota.

"Listen, we are on a mission to, in our founders' best vision of this country, return powers to the people," Rollins said.

The sentiment was in response to several farm groups sharing concerns related to government over-regulation. Specifically, that was related to Waters of the United States policy and endangered species regulations that were adding uncertainty to farming.

"Anything that can be done administratively would be great, legislatively would be more permanent, I presume," said Ryan Ellis, president of the North Dakota Grain Growers Association, concerning the Endangered Species Act. "The ESA to me is kind of terrifying."

Rollins said this topic came up in the White House in the last week and she asked that specific desires for these regulations be shared with Sen. John Hoeven, R-N.D., who helped orchestrate the gathering on Tuesday.

Trade concerns resonated with several attendees at the round table. Tony Richards, president of Northharvest Bean Growers Association, shared that the world eats dry beans, but concerns over implemented or even delayed tariffs are causing buyers to move away from the U.S.

"They are not canceling orders, but they are not making orders," Richards said. "So we are roughly about 25% down, and that market share has gone away to Brazil and Argentina.

And that, for us up here, and the United States as a whole, is a major issue, especially to our growers and processors." If the pain of lost markets continues, Richards said producers will need the certainty of crop insurance. As a specialty crop, dry bean growers don't receive the same disaster assistance as corn and soybean growers. Richardson along with several others are hopeful for unilateral trade agreements that can put U.S. farmers in a strong position to trade around the world.

Leaders of sunflower and canola groups shared concerns over the Make America Healthy Again movement that puts seed oils in a bad light. John Sandbakken, executive director of the National Sunflower Association, said he was hoping that Rollins would be a strong advocate for seed oils and the healthy benefits that they bring to consumers.

The importance of Farm Service Agency and Natural Resources Conservation District staff available to farmers was illustrated by North Dakota Farmers Union government relations director Matt Perdue. He shared how the number of attendees interested in learning more about programming for these groups has jumped. He said it's obvious that producers rely on those staff, especially as profit margins are thin for many crops.

Gov. Armstrong signs bill banning public school student cellphone use in North Dakota

North Dakota Gov. Kelly Armstrong went to a Bismarck elementary school Friday to sign a bill banning public school student cellphone use from "bell to bell."

"This is a game changer for our public schools, giving students the freedom to focus on learning and to interact with teachers and friends without the constant tug of their cell phones and addictive social media," Armstrong said in a statement.

House Bill 1160 would require public school districts to have policies requiring student cellphones be silenced and locked away during the entire school day on school grounds. The devices, including bluetooth-enabled devices, tablets, smartwatches or other wearable devices and gaming devices, must be stored in a lockable pouch, phone locker or other inaccessible locations.

The law allows students to use their phones while privately traveling to an off-site educational location, such as a career and technology center. It also allows school districts to craft their own cellphone-use policy during school-related noninstructional time, such as bus rides, field trips, sporting events and school dances.

Students with medical needs that require an electronic monitoring device and students participating in individual education programs may be exempted from the law.

School districts will also be required to collect data and compile a report on the impact of its cellphone policies on student behavior, mental health, disciplinary incidents, school attendance and academic performance during the interim.

State Superintendent Kirsten Baesler said teachers have told her that student mental health challenges have become more "overwhelming."

"This law gives students the gift of attention, connection, and presence. We are removing the constant pull of comparison and distraction and replacing it with space to learn and grow," Baesler said in a statement.

The new law will go into effect Aug. 1.

Lawmakers also are considering Senate Bill 2354, which would also restrict student cellphone use in private schools. The bill is being debated in a conference com-

mittee between the House and Senate. The next committee meeting is scheduled for Monday morning.

CITY OF ELLENDALE Regular Meeting April 14, 2025

6:00 pm – City Hall and Zoom Virtual
This meeting was held at the City Hall and virtual Zoom Meeting option was also available.

Mayor Flaherty called the regular monthly meeting to order at 6:00 pm with Council members in attendance: Belgarde, Lee, Langeliers, Denison, and Crabtree via Zoom. The Pledge of Allegiance was recited.

Absent: Meidinger

City Employees present: Auditor Kempf, Deputy Auditor Schmidt, Attorney Kelly; and PW Monroe via Zoom.

Others attending: W. Senger, Interstate Engineering; separate sign-in sheet available.

Library: There are some things taking up space in the library, asking for direction on what to do with a desk and a clock. Clock will move to City Hall and desk will be put up for sale with proceeds going to the library fund.

Bower's Tree Service: Based out of Frederick SD. Informed council a pest working its way towards Ellendale, wants to make sure Ellendale doesn't lose their trees to this disease. Educate the public, check trees for any issues, and do a tree inventory. Auditor Kempf, to get Bower's Tree Service information, will need to come up with a plan on how to continue.

Fair Board: The Fair Board expressed interest in the City-owned lot between the fairgrounds and Ellendale Public School Track. This property is used by the Fair board for parking during events held at the fairgrounds. With recent additions to the City of Ellendale the fair board is no longer able to use Ellendale Acres land. The Fair Board is inquiring about a potential lease to be developed for the usage of the land. Denison moves, Langeliers seconds to develop a long-term lease for 25 years for \$1/ year. Attorney Kelly purposes an amendment regarding the specifications of the lease agreement. Belgarde moves, Lee seconds the amended motion to have Attorney Kelly specify permitted uses, duration, amount, limited liability, etc. in the

lease agreement between the Fair Board and the City of Ellendale, to be read at a future meeting. All members, aye. Absent: Meidinger. Motion carries.

Ambulance Open Supervisor Position: Lee moves, Denison seconds to hire Wade Anliker as Full Time Paramedic Supervisor to start at \$60K a year plus benefits.

Ambulance Hall Update: Rebids for EMS Building came out better than the first time. Low bidder currently is \$2,031,000. Grant amount is \$1,500,000, city's share would be \$535,000. Ambulance grant would be used (40% roughly), and Capital Improvement and fund raising to offset the city's total cost. Denison moves, Lee seconds to accept Quest and move forward with contract, contingent on city engineer attempting to negotiate the price lower if possible.

Roll Call: Lee, Belgarde, Langeliers, Crabtree, Denison- Yes. Absent: Meidinger. Motion carries.

Ellendale Acres: Three phases will be paid through TIF. Two special assessment districts: Phase 1 & 2 for already developed lots for residential and commercial, Phase 3 would be all undeveloped residential lots to the east of the current developed lots. Bids opened with Comstock being the lowest.

Establishing an LLC to own the building would be a better idea. The City's involvement would be minimal, and no city council member would serve on the daycare board.

First Right of Refusal: Paul and Priscilla Brandenburger wrote to the city council requesting the city to release the first right of refusal they have on prop-

erty of theirs that is adjacent to Ellendale Acres. After discussion council decided not to sign off on this matter at this time.

Property on east side of Ellendale up for sale, too much for city to purchase, but should think about how city will grow and future development, all of which will be a part of strategic and comprehensive plans that are being put together now.

Building Permits: Belgard moves, Lee seconds to approve permit at TBC for new facility build east of existing building at 50 6th Ave S., all members, aye. Absent: Meidinger. Motion carries. Denison moves, Lee seconds to approve permit for Minnesota Petroleum Service, Inc, to place underground fuel oil piping for Applied Digital Data Center at 9685 87th Ave SE., all members, aye. Absent: Meidinger. Motion carries. Lee moves, Denison seconds to approve permit for Belgarde, outside improvements at 313 3rd St N., all members, aye, Belgarde abstains. Absent: Meidinger. Motion carries. Denison moves, Langeliers seconds to approve Mosbrucker permit for shed at 601 2nd St N, pending PW Monroe's sign-off, all members, aye. Absent: Meidinger. Motion carries.
