AN ORDINANCE AMENDING AND RE-ENACTING THE ZONING OR-DINANCE OF THE CITY OF BEU-LAH. MERCER COUNTY. NORTH DAKOTA SPECIFICALLY WITH RE-GARD TO CHAPTER 6, SECTION 6.15 BUILDING CODE ADOPTION, SECTION 6.16 BUILDING CODE DEVIATION, AND SECTION 6.17 BUILDING CODE MODIFICATIONS BY THE CITY OF BEULAH; CHAP-TER 10. Section 6.10 Enforcement Notice and Order

Whenever a zoning or code violation is found, the Building Official shall give written notification to the owner of the property that a violation has occurred and order the violation be abated and the property, building, or use brought into compliance with this Zoning Ordinance. A reasonable amount of time shall be allowed for compliance.

If a property owner or individual in possession of the premises is having work done on

the premises which requires a City issued building permit:

The Building Official shall issue a Cease-and-Desist Order stating the violation and required abatement. The property owner or individual in possession of the premises must cease all work and may not continue work until a valid building permit is obtained from

A Beulah police officer will visit the premises and serve the property owner or individual in possession of the premises the Cease-and-Desist Order issued by the Building Official.

If after service of the Cease-and-Desist Order work continues on the premises without a City issued building permit, each day that work continues shall constitute a violation of this Ordinance.

A violation of this Ordinance is an infraction which carries a minimum fine of \$250.00 per day and a maximum fine of \$1,000 per day, for each day work continues without a City issued building permit.

Contractors who are found to be providing services in the City without a valid state issued Contractor's license where such license is required will be reported to the North Dakota Secretary of State's office for investigation and prosecution if warranted. This will help ensure compliance with state regulations and discourage unlicensed activity.

If a Contractor is working at a premises within the City without having a State issued Contractor's license when required by this Ordinance:

The Building Official shall issue a Cease-and-Desist Order stating the and required The Contractor must cease all work and services being provided and may not continue such work and services until a valid State issued Contractor's license is obtained.

A Beulah Police officer will visit the premises and serve the Contractor the Cease-and-Desist Order issued by the Building Official.

Should Contractor continue to work and provide services at the premises after having been served with the Cease-and-Desist Order, said Contractor shall be reported to the North Dakota Secretary of State for investigation and prosecution if warranted. Such continued work and services after service of the Cease-and-Desist

Order shall constitute a violation of this Ordinance and each day that such work and services continue to be provided shall be considered a separate

Violation of this Ordinance is an infraction which carries a minimum fine of \$250.00 per day and a maximum fine of \$1,000 per day, for each day that such violation continues to occur.

(B) Action to Correct Violations

If any building or structure is erected, constructed, reconstructed, altered, repaired, converted, or maintained, or if any building, structure, or land is used in violation of this Zoning Ordinance, the proper local authorities of the City, in addition to other remedies, may institute any appropriate action or proceeding:

To prevent such unlawful erection, construction, reconstruction, alteration, repair, conversion, maintenance, or use;

To restrain, correct, or abate such violation;

To prevent the occupancy of the building, structure, or land; or

To prevent any illegal act, conduct, business, or use in or about such premises

(C) Penalty

Except as otherwise provided herein, any person, firm, or corporation violating any of the provisions of this Zoning Ordinance shall, upon conviction thereof, be punished by a fine of not more than one thousand dollars (\$1,000.00). Each and every day that a violation of this Zoning Ordinance shall be continued shall constitute and be considered a separate offense. A violation of any provision of this Zonor the regulations restrictions made herein shall constitute the maintenance of a public nuisance and shall be an infraction.

In a Garrison City Council Personnel Committee meeting Monday, May 12, the rest of the city council was informed of what the committee came up with for a severance package for Travis Tesch and Kaare Hallesy.

Previously, on Thursday, May 8, the committee had met with Tesch and Hallesy to get their input.

Tesch will receive eight-weeks' pay, vacation payout, and utility benefits will continue for eight weeks.
