New Salem man pleads 'guilty' to incident involving a head-on crash with deputy

Case closes with six felony, four misdemeanor charges

A New Salem man has pleaded "guilty" to 10 total charges after engaging in a police pursuit that ended with a head-on collision with a Mercer County Sheriff's Department deputy.

Dante Schwarting, born 1985, who was represented by court-appointed Attorney Omid Kardoust, pleaded "guilty" in March to six felony charges and four misdemeanor charges from a February incident.

Below are a list of the charges and the sentences handed down with each one to be served concurrently:

Count 1: Possession with intent to manufacture/deliver – methamphetamine (class B felony): sentenced to 10 years in the department of corrections and rehabilitation with credit for 47 days served; with four years and 10 days suspended and three years supervised probation.

Count 2: Criminal mischief – willful damage – intentional more than \$10,000 (class B felony): sentenced to 10 years in the department of corrections and rehabilitation with credit for 47 days served; with four years and 10 days suspended and three years supervised probation.

Count 3: Fleeing a peace officer – vehicle – fleeing from felony (class C felony): felon or violent misdemeanor (class C felony): sentenced to five years in the department of corrections and rehabilitation with credit for 47 days served plus three years supervised probation.

Count 4: Unlawful possession of a firearm – felon or violent misdemeanor

(class C felony): sentenced to five years in the department of corrections and rehabilitation with credit for 47 days served plus three years supervised probation.

Count 5: Theft-possession- firearm, ammunition, explosive/destructive device (class C felony): sentenced to five years in the department of corrections and rehabilitation with credit for 47 days served plus three years supervised probation.

Count 6: Unlawful possession of drug paraphernalia-use-SI, SII, SIII – second offense (class C felony): sentenced to five years in the department of corrections and rehabilitation with credit for 47 days served plus three years supervised probation.

Count 7: False information to law enforcement (class A misdemeanor): sentenced to 360 days in the department of corrections and rehabilitation with credit for 47 days served, plus three years supervised probation.

Count 8: Reckless endangerment (class A misdemeanor): sentenced to 360 days in the department of corrections and rehabilitation with credit for 47 days served, plus three years supervised probation.

Count 9: Reckless driving-rights/safety (class B misdemeanor): sentenced to 30 days in the department of corrections and rehabilitation with credit for 30 days served, plus three years supervised probation.

Count 10: Driving under suspension (class B misdemeanor): sentenced to 30 days in the department of corrections and rehabilitation with credit for 30 days served, plus three years supervised probation.

In addition to the sen-

tencing, Schwarting will also have to pay \$29,760.95 in fines and fees, with \$236.25 applied in credits.

THE INCIDENT

According to an affidavit received by District Court 29 for the case, which was prepared by Mercer County Sheriff's Deputy Brandon Doll, 9-1-1 dispatch informed Doll on Feb. 8 Schwarting stopped in at the jail to post bond for another individual. It was confirmed he had a no-bond warrant with full extradition out of the state of Minnesota. However, Schwarting left the jail "moments prior" to Doll arriving with two additional people in the vehicle.

Dollw was able to locate the vehicle and conducted a traffic stop on Harmon Avenue near Main Street in Stanton. Upon approaching the vehicle, the driver gave a false name, stating he had no ID on him.

As Doll reapproached the vehicle on driver's side, the driver "sped away and a vehicle pursuit started."

The affidavit stated the vehicle went down Harmon Avenue across from N.D. Highway 31 and continued westbound down a section line

"As the section lined ended, the vehicle crashed through a barbed wire fence and went into a pasture," the court documents stated. "The vehicle continued through the pasture then went through an open gate into a harvested soybean field."

The pursuit continued, resulting in the car crashing through another fence on the northside of the section line. The driver then went back westbound down

SLOPPY JOE CASSEROLE

1 Tbsp. vegetable oil 1 lb. ground beef Kosher salt

Freshly ground black pepper
1 medium yellow onion, chopped
2 hell pepper seeds and ribs removed of

1 green bell pepper, seeds and ribs removed, chopped 1 red bell pepper, seeds and ribs removed, chopped 2 cloves garlic, finely chopped

2/3 cup ketchup

1 Tbsp. chili powder

1 tsp. dried mustard

1 (8-oz.) can tomato sauce

1 cup low-sodium beef or chicken broth

2 Tbsp. apple cider vinegar 2 Tbsp. Worcestershire sauce

2 tsp. dark brown sugar

Hot sauce (optional)

8 sweet Hawaiian slider rolls, halved crosswise

1 Tbsp. unsalted butter, melted

1 cup shredded cheddar

Chopped fresh parsley, for serving (optional)

Step 1. Preheat oven to 375°. In a large skillet over medium-high heat, heat oil. Add beef; season with 1 teaspoon salt and 1/2 teaspoon pepper. Cook, breaking up beef with a wooden spoon, until crumbled and no longer pink, 6 to 8 minutes. Using a slotted spoon, transfer beef to a plate. Pour off all but 1 tablespoon fat.

Step 2. In same skillet over medium heat, cook onions, bell peppers, and garlic, stirring occasionally, until vegetables are softened, 10 to 12 minutes; season with salt and pepper. Add ketchup and cook, stirring occasionally, until ketchup is reduced to a thick paste, 5 to 6 minutes. Add chili powder and mustard and cook, stirring, until fragrant, about 30 seconds. Add tomato sauce, broth, vinegar, Worcestershire, and brown sugar and cook, stirring, until combined. Add beef and a few dashes of hot sauce (if using).

Step 3. Transfer to a 2-quart baking dish. Top with rolls cut sides down (both the tops and the bottoms, for a total of 16 halves). Brush with butter and sprinkle with cheese. Step 4. Bake casserole until rolls are toasted and cheese is melted, 10 to 15 minutes. Sprinkle with parsley (if using).

Set meetings are as follows:
