

Dickey County Commission Minutes May 20, 2025

Commissioner Meeting
May 20, 2025

Chair Brandon Carlson called the meeting to order at 9:01 am. Commissioners John Hokana, Jerry Walsh, Kacey Holm, and Marke Roberts were also present. Auditor Sheppard and OtterTail Power Company Kris Koch was also present. The media was not present. The Pledge of Allegiance was recited. States Attorney Kim Radermacher, Administrative Assistant Monica Pakonen, Clerk of Court Andi Schimke, Dickey County Sheriff's office, Applied Digital Martin Vega, and resident Cindy Bagley were in attendance via electronic means.

Roberts made a motion to approve the May 6th meeting as amended. Holm seconded. Motion carried.

Sheppard presented three additional vouchers to be approved, one for \$142.67 to Central Business Systems, one for \$576.43 to JPMorgan, and \$20,000.00 to Fellows Coffee. Walsh made a motion to approve the vouchers with the additions. Holm seconded. Roll call was unanimous. Motion carried.

The April 2025 financials were reviewed. Treasurer Wonada Lematta joined at 9:20 to discuss the interest on the CD's listed at the bottom of the report. Walsh made a motion to authorize Lematta to purchase \$2,000,000 in CDs in 6 month CDs at the best interest Lematta locates. Holm seconded. Roll call was unanimous. Motion carried. Lematta will inform the Commission of the percentage of received on the new CDs.

Hokana made a motion to approve the financials. Holm seconded. Roll call was unanimous. Motion carried.

Lematta presented the quarterly pledge report for first quarter 2025. Roberts made a motion to approve the pledge report. Holm seconded. Roll call was unanimous. Motion carried.

Schimke discussed with the Commission an issue with the person hired to mow the county park at Pheasant Lake. A new bid has been submitted, not using the county equipment. Carlson stated that Highway Superintendent Hagen stated that the individuals hired as summer help at the highway shop could do the mowing. A decision was made to use the summer help and Deputy Auditor Stormy Bertsch would be a backup. Schimke requested an hourly rate if other work needed to be done outside of county hours. Based on the bids received, a decision was made to pay \$25 per hour.

Applied Digital representatives Martin Vega and Andrea Mireles joined the meeting at 9:48. Tax Director Don Flaherty joined the meeting at 9:55.

Schimke discussed the mowing residents are doing on county park property at Pheasant Lake. The Commission asked Radermacher for clarification if restrictions were on the original deed which would not allow the Commission to sell the property. Radermacher stated there are no restrictions on the original deed. Holm made a motion to authorize Radermacher to send a letter to all landowners at Pheasant Lake, informing them not to mow county property. Walsh seconded. Roll call was unanimous. Motion carried.

Holm made a motion to open the abatement hearing. Roberts seconded. Motion carried.

Flaherty presented a homestead credit application for one parcel, which qualifies for 50% credit for tax year 2024 and 100% credit for 2023. Holm made a motion to approve the homestead credit application. Hokana seconded. Roll call was unanimous. Motion carried.

Holm made a motion to close the abatement hearing. Roberts seconded. Motion carried.

Holm made a motion to open the omitted tax hearing. Hokana seconded. Motion carried.

Flaherty presented 25 parcels that have prorated omitted tax for tax year 2025 for property purchased in 2024 that converted from exempt to non-exempt for tax purposes. The reason for most of these properties was the deeds were recorded in the Records Office at the end of 2024 after tax statements were mailed. Walsh made a motion to approve the 25 parcels to be added to the tax rolls. Holm seconded. Roll call was unanimous. Motion carried.

Holm made a motion to close the omitted tax hearing. Walsh seconded. Motion carried.

Flaherty, as Ellendale City Mayor, informed the Commission that Ellendale City Council feels they will not be able to assess the loan for the improvements on 87th Avenue up to 95th Street to Highway 281. Discussion included the fact it will need to be worked out between Applied Digital's lawyer, City of Ellendale's lawyer, and the County States Attorney.

The meeting went into recess at 10:10 and returned at 10:18.

Holm presented a rough draft of the zoning ordinances that have been worked on by the Zoning Board. Holm and Roberts reported to the Commission on the contents and how the board has worked together. Holm specifically pointed out pages 78, 82, and 100. Roberts stated there is a system in place in the

ordinances allowing for waivers. The Board has worked at not hindering any commerce development in the County and feel they are giving townships room to develop their own ordinances.

KLJ Engineer Bryan Tykwinski joined the meeting at 10:45. Elden Township representative Gary Dathe joined the meeting at 10:48. Highway Superintendent Jeff Hagen joined the meeting at 10:50.

Sheppard presented a contract with Vanguard Appraisal to complete final assessments for the new buildings at Applied Digital when they are complete. Roberts made a motion to sign the contract. Holm seconded. Roll call was unanimous. Motion carried.

Hagen presented a blading contract from Young Township. Holm made a motion to sign the contract. Walsh seconded. Motion carried.

Hagen presented a blading contract with the City of Monango. Holm made a motion to sign the contract. Roberts seconded. Motion carried.

Hagen stated he had received a quote to do patchwork on County Road #2 and the bridge by Maple River Colony on County Road #8. The quote was \$11,749.75 for County Road #2 and \$19,480.12 for the bridge on County Road #8. Holm made a motion to approve the patchwork done at both locations. Walsh seconded. Roll call was unanimous. Motion carried.

Discussion followed concerning the county gravel pit on Highway 56. It is a 37-acre pit that is sandy. Discussion included trading gravel for the sand, if someone was interested. Discussion also included the possibility of selling the land, if we are not going to use it.

Dathe spoke with the Commission on converting 87th Avenue to 95th Street in Elden Township to county road. Dathe stated the township is still willing to turn the road over to the county. There has not been a plan for it, but the township would like to see one, as they have some areas of concern. An additional culvert should be considered at 88th Avenue, which Tykwinski stated should have a hydrology study. Dathe stated one had been done for FEMA a few years ago. Sheppard will see if that study can be located and will give a copy to Tykwinski. Discussion followed that the legal paperwork needs to be in place. Radermacher stated that there should be a motion and a resolution made by Elden Township. The rules of House Bill 1444 should be followed. The Township and the County each need to have a special meeting to meet those guidelines. The township could meet and then the Commission meet following that meeting. Sheppard will work with the township to get the

agendas in the paper. The meeting will be on June 10th, with time and location to be set.

Tykwinski stated he would like to have a predesign meeting with the County and Elden Township. Carlson stated he would attend the meeting. Tykwinski will let Carlson know the time and date of the meeting. Roberts questioned if the motion made to start this process should be revoked since the Memorandum of Understanding agreement is different than the original agreement presented at the Commission meeting. That revoke will be completed once the agreement is finalized.

Tykwinski presented the design engineering contract for Dickey County #3 east of Oakes in the amount of \$40,000. Hokana made a motion to sign the contract. Roberts seconded. Roll call was unanimous. Motion carried. The bid opening is June 20th with a start date in August.

Carlson updated the Commission on the drain on County Road #12 that John Quandt spoke with the Commission about. US Fish and Wildlife has approved the project but there are issues with the NRCS that are being worked through. The cost of the project will be approximately \$36,000, with the Water Board paying half of the cost and the county paying the other half.

Hokana made a motion to adjourn at 12:00 pm.
