ND farm numbers unchanged

North Dakota's number of farms and ranches remained unchanged during 2024, according to USDA's National Agricultural Statistics Service. The number of farms and ranches in the state, at 24,800, was unchanged from 2023. Numbers of farms and ranches in North Dakota with less than \$100,000 in agricultural sales increased

100 farms from a year earlier while operations with more than \$100,000 in agricultural sales decreased 100 farms.

Land in farms and ranches in North Dakota totaled 38.5 million acres, unchanged acres from

2023. The average size of operation, at 1,552 acres, was unchanged from a year earlier.
