The Steele County Board of County Commissioner's would like to extend an invitation for gravel bids for the year of 2025. The roads to be graveled are:

CR 7: 8 miles North of the City of Sharon to the Steele/Nelson County Line

CR 16: 5 miles North of ND Hwy 32 to the Steele/Grand Forks County Line

CR 10: 6 miles between ND Hwy 200 and CR 11

CR 15: 2 miles East of CR 10 to the Steele/Trail County Line

CR 8A: 4.5 miles West of CR 6 to ND Hwy 32

CR 6: 8 miles North of the City of Hope to CR 11

The total mileage to be graveled is approximately 33.5 miles. The Steele County Commission will only be accepting gravel bids for CRUSHED GRAVEL. Gravel bids MUST INCLUDE pricing from Sibley and Fordville Pits. All other pits submitted for consideration will be subject to review by the Steele County Highway Superintendent before an award. Gravel bids MUST ALSO INCLUDE separate pricing from each of the pits for the Steele County Highway Department to load and haul gravel.
