100 years ago

Prices for penitentiary twine have been established this year at the same level as the Minnesota twine prices. There is an increase due to the increased cost of raw materials. Prices for 1925: 500-foot standard twine, 11 j cents per pound; 600-foot manila, 13 s cents per pound; 650-foot pure manila, 15 j cents per pound. Last year's prices, respectively 10 3-4, 12 and 13 cents per pound.

Many inquiries have been made of the States Attorney as to the new Cigarette laws. One question is whether the full \$10 license fee must be paid for the period from April 1 to July 1, 1925. Owing to the way the law is written, dealers applying for license must pay \$10 as a fee up to July 1st, after which date, the fee is \$10 for the following year.

Others inquire how the dealer is to know if a buyer of cigarettes is 21 or not. The answer is that the dealer sells at his own risk. If the buyer should not be 21, the law would be violated, although the dealer might show his good faith as an extenuating circumstance.

The law applies to cigarette papers as well as cigarettes.
