Emily treasured her role as a grandmother. Her kitchen table was the heart of the home, where she baked goodies with the grandkids and kept watch over the calving pen and other farming activities. Her grandchildren held a special place in her heart.

A graduate of Parshall High School in 1968, Emily went on to attend North Dakota State University. There, she was a member of the marching band, Phi Mu sorority, and earned her bachelor's degree in special education. She began her teaching career in West Fargo before following her heart back to rural life.

Emily is survived by her loving husband of 50 years, Lorin; and their four children: Deric (Sara), Roark (Abigail), Sheena, and Tyrel. She was a proud and devoted grandmother to Brandon, Tyler, Ryan, Sydney, Emma, Jake, Reece, Collin, and Iyla, and a great-grandmother to Oliver.
