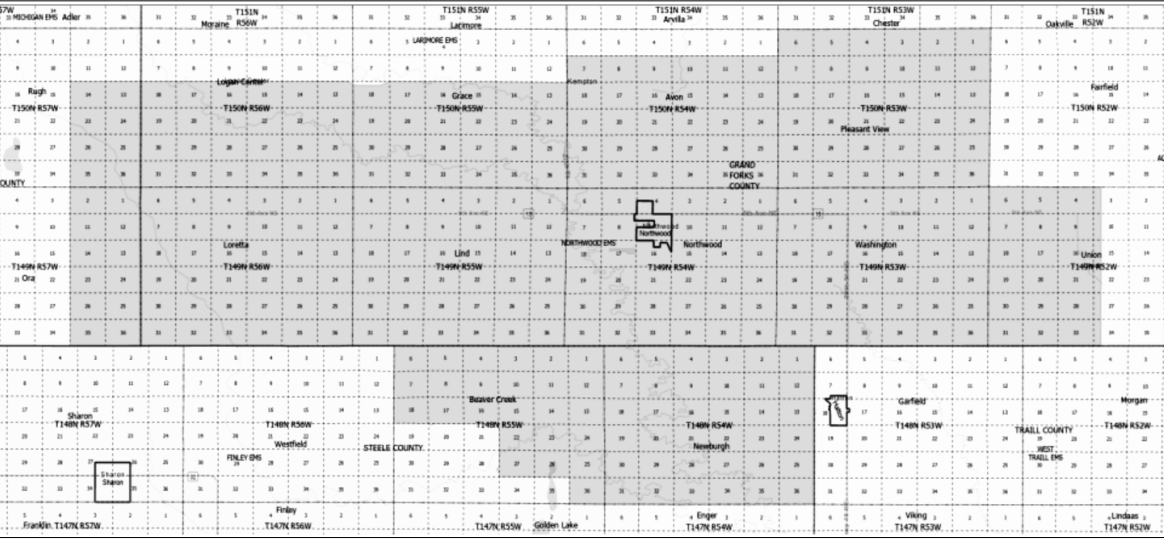

DITCH MOWING NOTICE

The Grand Forks County Weed Control Board, at the direction of the Grand Forks County Commission, has determined that the control of noxious weeds along all township roads has become a serious problem. Accordingly, pursuant to Grand Forks County ordinance & North Dakota State law, all township roadside ditches must be mowed by adjacent owners and/or operators, to a height of no higher than 10 inches
