May 8, 2025

On April 21, 1993, Governor Edward T. Schafer approved House Bill No. 1028 that established a program to provide specialized telecommunications services and equipment to the communications impaired. The relay services program is funded by an ac-cess line surcharge paid by the customers of local exchange companies and radio communications service providers.

The relay services program is admin-istered by the Information Techno-logy Department of the State of North Dakota. Before June 1 of each year, the Public Service Commission calcu-lates the amount of the surcharge based on cost data and other information provided by the Information

Technology Department. The Commission has calculated the 2025-2026 surcharge to be included in bills to customers is \$.03 per access line per month
