The first quarter ended with the Titans leading 18-8. In the second, Brady Haugen racked up 12 points for the Titans, contributing to the 18 points they scored that quarter, and the half ended with the Titans up 36-31. The Titans just barely kept their lead at the end of the third quarter, with a score of 49-48. The Chargers pushed hard in the fourth, pulled ahead of the Titans, and won the game 58-57.

Both teams put up 17 points, but the Warriors pulled away with a 67-53-point win.
