TAKE NOTICE that the Department of Water Resources has initiated the cancellation process for a portion of Perfected Water Permit No. 1989 for three or more years of successive non-use. The permit is held by FEIRING, DUANE AND JANELL, for the annual use of 290.0 acre-feet of water from the Spiritwood aquifer for Irrigation purposes. The authorized pumping rate is 1,625 gallons per minute. The priority date is October 11, 1973. The points of diversion are NW1/4 of Sec. 15 and the SE1/4 NW1/4 of Sec. 19, both of T. 148 N., R. 061 W., Griggs County.
