The Hettinger City Council met in regular session at the Hettinger Armory Conference Room with the following present: Mayor James Lindquist, Randy Burwick, Michele Gaylord, Carl Ebert and David Parrill.

Mayor Lindquist called the meeting to order at 7:00 a.m.

FINANCIAL STATEMENT: Reviewed, Council er Ebert moved to approve the financials, second by Council Member Parrill, and unanimous vote, motion

CORRESPONDENCE Council Member Gaylore Gaylord discussed a contract signed in October 2024 for Nexus write a grant for water/ sewer infrastructure updating funds. A grant has opened for this, so Nexus is ready to get started and will need to start work on an application and will need information from Brosz Engineering. Ms. Gaylord discussed several complaints on feral cats over the last month. Ms. Gaylord requested an attorney's opinion on our ordinance and saw no issue with the wordage and protocol. Ms. Gaylord has also tried to research ways to start a rescue house to help with the number of cats. Other ideas discussed were the possibility of fining people feeding stray cats, as the amount of wildlife that has come into town has increased. The Council was in favor of someone starting a shelter. Several people have requested information on if it was legal to trap cats or other animals on their property. It was decided to have each individual work with

the Sheriff's Office.
CONNECTION CHURCH Luke Stadheim and Mike Knuth met with the Council to discuss the setup with having the church housed in the armory. Mayor Lindquist discussed the agreement set up was for a temporary basis and discussed a possible increase agreement. The group is still looking for a new property and understands there would be an increase

ARMORY MAINTENANCE CUSTODIAN: Fitness Center membership money brought brought in last month was \$1,285.00. Updates were given on the fitness center. Several items were fixed and resistance bands have been added. The impound lot has been completed, the armory maintenance department does not have access to the camera, but the Sheriff's Office should. The Commission discussed Mayor Lindquist the larger cost of privacy slots. Discussion was if they were actually needed. The Council was really wanting to have the included slats, and decided that they would pay for the slats, with the willingness to remove the \$1,300 per month rental fee for county shop space they are being charged. Ms. Schalesky also requested a reduction or no fee rental for an upcoming medical benefit or requesting a donation. Discussion was had on having the Lions Club could come back and request sales tax funds for the reimbursement of rental of the armory. Council Parrill moved approve donating one single membership to the fitness center for a silent auction item, second by Council Member Burwick. and by unanimous vote; motion carried. Discussion was had on the school agreement and other

rental agreements R O A D SUPERINTENDENT-JUSTIN BLADE: met with the Council to update on his department. The crew cleaned up the nuisance yard and has been working on the city holding pond, as it is plugged. Mayor Lindquist was notified that there was a large amount of weeds at the end of the Street by the Legion. A group of people had cut them down, but was wondering about getting them removed. Mayor Lindquist also discussed putting together a list of items for the city portion of a job description for a new employee

ACDC UPDATES: Council Member Gaylord discussed the grant was submitted for the bowling alley. No meeting minutes were available to review from meetings.

SALES TAX REPORT: Was reviewed.

Mr. Roehl discussed concerns about roof damage and hoped maybe an extension to the existing lease, which ends October 31. Mr. Roehl was hoping to possibly extend the lease agreement until at least the end of year. Mr. Roehl has also been working on funding to purchase the building if a grant is not obtained Council Member Gaylord Gaylord moved to approve an extension of the lease agreement through December 31, 2025, second by Council Member Burwick, and by unanimous vote; motion

carried.

Nexus is working on grant funding for lagoon work; Brosz Engineering is working on inventory and needs of sewer and water piping. Council Member Ebert moved to approve the rebate contract for the camera project, second by Council Member Parrill, and by unanimous vote; motion carried. An amendment to the project in the amount of \$17,500.00 to complete the camera project to both wastewater and freshwater was reviewed.
