Flasher City Council Regular Meeting April 9, 2025

The regular monthly meeting of the Flasher City The monthly Commission was called to order by President Schmidt at 7:00 Commissioners Meyhoff, and Gessey were present. Commissioner Schluchter was absent. Also present were Dereik Rich, Garrett Clark, AJ Tuck, Don LaFleur, John Achtenberg, Lori Dirk, Jerlyn Gabrielson, Neil Gabrielson, and Riley Dahl.

Schmidt asked all to stand for the Pledge of Allegiance and reminded all we will be using Roberts Rule of Order.

Schmidt called to order the Board of Equalization meeting at

7:02 pm. Board of Equalization: Donald LaFleur from the Morton County Tax Equalization Office presented and discussed the 2025 Annual Assessment of property. Mr. LaFleur stated our parcels within city limits have a true and full value with of \$10,979,100. These values are based off data that is collected and occurring in Flasher only and not what occurs in other areas of the county. There was and adjustment requested due to an inspection on properties 62-0404205 and 62-0404220 for the amount of \$78.300. With the adjustments the true and full value will total \$10,900,800. No appeals were requested. Motion to approve the true and full values with the adjustment. (Meyhoff/ Gessey). With all voting in favor, motion carried. Motion to adjourn the Board of Equalization meeting. (Meyhoff/Gessey). With all voting in favor, motion carried.

Motion approving March 12 meeting minutes. (Gessey/ Meyhoff). With all voting in favor, motion carried.

AJ Tuck from Moore Engineering presented the Engineer Report. Informed the commission that discussion have continued with the USDA in regards to the RD Loan. They are backed up due to employment layoffs and are looking at being low on funds. A change order was put in for the water meter project. There were no changes in the cost, the only changes made were specific wording requirements for the SRF Loan. Motion to approve change order #1. (Meyhoff/ Gessey). Roll call vote – all aye. With all voting in favor, motion carried. Discussed grant option for the walking path. Motion to approve Moore Engineering apply for Recreational Trail Program grant. (Meyhoff/Gessey). With all voting in favor, motion carried. Motion to cover up to \$7500 for the application for the grant. (Meyhoff/Gessey). With all voting in favor, motion carried, Mr. and Mrs. Gabrielson were present to

ask questions and discuss concerns with location of the walking path. Service Line Inventory discussed. It was decided to wait to do the door-to-door portion of the continuing work to complete the service line inventory in conjunction with the water meter project.

Garrett Clark from MAP presented the Rate Study that was conducted for the City of Flasher. The rate study evaluated and analvzed the rates for wastewater and water for the city.

Planning 8 Committee – tabled. Zoning

Commission discussed the formal agreement with GPBG Employer Advisors in regards to the strategic plan for the city of flasher. Motion to approve paying the \$4000 agreement fee. (Meyhoff/Gessey). With all voting in favor, motion carried.

Commission discussed purchasing a wheel packer for road work in the city. Motion to approve spending up to \$8000 for a packer, if can find one. (Gessey/ Meyhoff). With all voting in favor, motion carried.

Tank Cleaning Bids were opened. Midco offered cleaning and inspection for \$3498 and 2 options for different types of reports. Veit offered to complete the cleaning and inspection for \$9300. Motion to award the bid to Midco for cleaning and inspection of \$3498, and the confidential report utilizing EPA guidelines for \$368. (Meyhoff/Gessey). Roll cal vote - all aye. With all voting in favor, motion carried.

Schmidt informed commis-

sion about a resident who experienced sewer trouble and repair requirements due to the sewer connection from the empty city owned lot across the ally. Since the issue was caused by the city property discussion was held regarding responsibility of cost. Motion to approve paying the repairs to Blanchard sewer for damages caused by city owned lot. (Meyhoff/Gessey). With all voting in favor, motion carried.

Commission reviewed the updated Lince contract with the changes made and approved at the last city meeting. Motion to Lince Contract as newly revised. (Meyhoff/Gessey). Roll call vote all aye. With all voting in favor, motion carried.

President Schmidt would to remind residents that City Dumpsters are for HOUSEHOLD TRASH ONLY. Anything else needs to be disposed of at an available landfill.

Motion to open the landfill and hold OPEN DUMP DAY on May 3rd from 10 am to 2 pm and to approve the calendar with the open dates, with noted corrections. All open dates weather permitting. (Meyhoff/Gessey). With all voting in favor, motion carried. Calendar will be mailed out to residents with next utility bill and available at the office.

Motion to approve mileage reimbursement for Alesia and Sherry. (Meyhoff/Gessey). With all voting in favor, motion carried. Schmidt abstained. Motion to approve 3% raises for Dereik, Daniele, and Alesia effective starting the current pay period. (Meyhoff/Gessey). With all voting in favor, motion carried.

Motion approving checks written. (Meyhoff/Ġessey). With all voting in favor, motion carried. Motion to approve March financials. (Meyhoff/Gessey). With all voting in favor, motion carried. Motion to approve POs. (Gessey/Meyhoff). With all voting in favor, motion carried.
