## Angler Lands Record Tiger Trout

Minot angler Evan Trottier caught a state record tiger trout through the ice Jan. 4 at Hooker Lake in Rolette County.

Trottier's 6-pound, 2-ounce trout was verified by North Dakota Game and Fish Department personnel. This fish also measured in at 24.75 inches.

The Game and Fish Department started stocking tiger trout in 2023 as a novel sport fish in select lakes. Tiger trout are a hybrid between a brown trout and brook trout, known for their namesake striped coloration and fast growth rates in the right environments. Only a handful of lakes in North Dakota contain the right combination of habitat, water quality and forage for tiger trout to thrive.

In spring, the Game and Fish Department plans to stock tiger trout in Hooker Lake and Strawberry Lake in the Turtle Mountains, Moon Lake near Valley City, and the Garrison Dam Tailrace.

Tiger trout stocked in North Dakota waters are obtained through a working partnership with the Wyoming Game and Fish Department.

## Legacy Trail in Rolla turns into multi-use path, connecting to St. John

ROLLA, N.D. (KMOT) - If you're an outdoor enthusiast, there's one trail you may want to check out in the northwest part of our state.

This trail is more than just a path. It honors the town's history while opening the door to outdoor recreation, serving as a gateway to the Turtle Mountains.

The eight-mile path connects the towns of Rolla and St. John. It used to be a railroad bed, but sat unused for years.

"Residents really appreciate that they have a place to exercise," said Rebekah Bryant, economic development director for the City of Rolla.

Bryant said the community rallied together to clear it up and make it a trail for walkers, bikers and runners.

"The old tracks were removed and then converted into this walking or hiking trail," said Bryant.

Joshua Steffan with the state Parks and Rec said there's an app called OuterSpatial where

you can find this trail among others like it across the state.

"That app includes not only state park trails, but all the trails statewide," said Steffan.

These days don't offer long daylight.

"We go to work in the dark, we come home in the dark, usually," said Steffan.

But this trail offers a reason to step outside when you can.

"I think if we can get out and enjoy the outdoors and remain a little more active than we usually be, I think that's really important," said Steffan.

Beyond exercise, this trail tells a deeper story, one rooted in the town's legacy.

"In the City of Rolla, we really want to continue to allow our residents to want to live here. And our visitors to want to visit and stay here," said Bryant.

The trail is open all year long, located off Highway 30.

The state Parks and Recreation said they are working on including this trail and other city and county ones to the annual Hiking Challenge in the future.
