Charles Patrick "Pat" Mahrer, age 79, entered into his eternal rest on January 8, 2026. Pat was born to Charles "Chuck" and Ellen (Oland) Mahrer in Britton, SD. He was raised in Forman along with his sisters Rita, Pam, and Candy. He graduated in 1964 from Sargent Central High School in Forman, ND. In 1965, the family moved to Hankinson where he worked for his dad at the gravel pit by Lake Elsie. That same year, on a fateful Friday evening, Pat noticed a certain young gal walking with her friend in the cool fall air and offered them a ride in his 1962 Chevy Super Sport (white with red interior). It was love at first sight. Linda loved that car and soon, she and Pat were insepara-

ble. So began a love story for the ages. Pat and Linda were engaged on Christmas Eve and married at St. Philip's Catholic Church in Hankinson, ND, on July 6, 1966. They made their family home in Hankinson. Pat's life was distinguished by service to others: his family, his country, and his community. Family was first. Pat and Linda raised three boys and created many happy memories with them: trail riding, camping, boating, fishing, hunting, and riding in the truck. They would later share many of these pastimes with their beloved grandchildren. He was extremely proud of his three boys, grandchildren, and great-grandchildren and left them a legacy of valuable lessons: steadfastness, hard work, faith, and unconditional love. Pat loved and was loved by his extended family. To Pat, family were friends and friends were family. He always had time for a cold beverage and a visit on the patio. Pat was exceptionally proud of his military service. In March of 1966, he was drafted into the United States Marines (Semper Fi). Pat was wounded in combat in Vietnam and awarded the Purple Heart. In the Marines, he found a family of brothers with whom he would share an indivisible bond. Upon his return to Hankinson, Pat continued to serve. He was a member of the Community Betterment Club, Hankinson Centennial Committee, and St. Philip's parish where Pat served on the pastoral council, ushered, and assisted Linda with the Catholic Youth Organization (CYO). A lifetime member of Disabled American Veterans, Military Order of the Purple Heart, and the Hankinson American Legion Eberhard Post 88, Pat spent countless volunteer hours working at the Hankinson American Legion Memorial Site, a memorial for his brothers in service. Pat spent most of his working life in the family business, Mahrer Construction, later Bernard Mahrer Construction. Later, he ran the motor grader for Brightwood Township and helped as an equipment operator at Falk Drilling. He was a hard worker and proud of the work he did. Pat enjoyed retirement. Relatives take sides as accusations and denials pile up

DEAR ABBY: I'm a 51-year-old mother and grandmother whose kids don't talk to me. The reason: My son, "Aaron," was sexually assaulted by his friend, "Eli," and I told him his friend was

no longer allowed to come over. I spoke to Eli's mother. She told me she'd take care of it and agreed the two shouldn't hang out. They were both underage at the time. (Aaron was 10, and Eli was 13.)

A few months later, Aaron told me that it wasn't Eli but his own uncle "Joe" who sexually assaulted him. I knew better. I talked to Joe and, of course, he knew nothing. I told Aaron to stop lying about his uncle and that Eli still couldn't come over.

Aaron is an adult now, and he's got his siblings believing him about his uncle, and he's still friends with Eli. My husband and I moved next door to Joe, and now all the kids have blocked me from their and their kids' lives. When I tried to talk to Aaron about the situation, he blocked me completely. Joe knows nothing about what's going on. How do I get back into my children's and grandkids' lives?

DEAR TURNED: Could the boys have been experimenting with getting familiar with their bodies when all this occurred? Did you see something and confront your son and he admitted it? Aaron may have blamed Uncle Joe because he wanted to continue seeing Eli. Or ... was his accusation TRUE? You will not be able to heal the schism in your family until everyone is in agreement about what really happened when Aaron was 10.

I ask because a beneficiary's Social Security number and/or passport number is NOT REQUIRED when someone is being mentioned in a will, and I think you may have dodged a bullet.

George Defender, Bronc Rider

January 14, 2026 — The annual Cowboys Reunion Rodeo started out somewhat accidentally at the first Mercer County Fair in 1915. Among the exhibits was a shorthorn bull, and Frank Chase of Fort Berthold decided he wanted to ride it — which he did. The crowd was impressed and passed a hat, and Chase walked away with \$30.

It was the first rodeo event in Beulah, and in the following three years, rodeos became an annual event there.

Ed Boland described how it all began: "One day during the month of August, I was mowing along the creek when A.

D. Brown, the newspaper editor, and George Slowey, an area businessman, came driving across the flat in a shiny new contraption. They stated their mission flatly — 'Could we stage a rodeo at Beulah the following month?' ... When they left some two hours later, the foundation had been laid for the now famous Cowboys Reunion Rodeo.

One of the riders in that first year was George Defender. He was born in South Dakota in 1891 and started working as a "rough string" rider for the DZ Cattle Company at Standing Rock when he was 16.

Most of George's spectacular rides never got into the record

books. One of these was a first-place win in Montana at the 1914 Miles City Roundup. The Roundup was one of the biggest rodeos on the circuit, and Defender quickly earned a reputation as a top bronc rider. He competed all over the continent, including wins at Madison Square Garden and the Calgary Stampede. At one point, he was a finalist for the world championship as all-around cowboy.

George also competed in wild horse races, bulldogging, wild cow

milking, bareback riding, calf roping, relay races and buffalo riding. His ranch was on the Standing Rock Reservation, but he later worked in Arizona after contracting tuberculosis. 
